

IN THE EVENT OF A **STRIKE!**

YOU CAN KEEP YOUR CURRENT MEDICAL COVERAGE.

COBRA, WWW.DOL.GOV// (1-800-482-4105) IS A FEDERAL LAW THAT GIVES STRIKING WORKERS THE OPPORTUNITY TO CONTINUE THEIR HEALTH PLAN COVERAGE.

LOCKHEED MARTIN MUST NOTIFY THE ADMINISTRATOR (CONEXIS) WITHIN 30 DAYS OF THE STRIKE.

THE ADMINISTRATOR (CONEXIS) MUST THEN SEND A LETTER TO THE STRIKING WORKER WITHIN 14 DAYS.

THE STRIKING WORKER HAS UP TO 60 DAYS TO SIGN UP FOR COBRA COVERAGE. PAYMENT IS NOT REQUIRED FOR 45 DAYS AFTER SIGNING UP. IT IS RETROACTIVE BACK TO THE FIRST DAY OF THE STRIKE.

IF YOU DO NOT REQUIRE ANY MEDICAL SERVICES BY THE END OF THE 105 DAYS (60 DAYS + 45 DAYS) YOU CAN CANCEL THE COVERAGE AND PAY NOTHING.

IF YOU DO REQUIRE MEDICAL SERVICES, BE AWARE THE ADMINISTRATOR WILL NOT PAY THE BILLS UNTIL 100% OF THE PREMIUM PLUS A SMALL ADMINISTRATIVE FEE IS PAID.

MEDICAL CARE FOR YOUR CHILDREN: YOUR CHILDREN MAY BE ELIGIBLE TO RECEIVE HEALTH CARE INSURANCE THROUGH PEACHCARE. THIS STATE RUN PROGRAM PROVIDES COMPREHENSIVE HEALTH CARE TO CHILDREN THROUGH THE AGE OF 18.

THERE IS NO COST FOR CHILDREN UNDER THE AGE OF SIX, AND THE COST PER MONTH IS \$10 TO \$35 FOR ONE CHILD AND \$70 FOR TWO OR MORE CHILDREN LIVING IN THE SAME HOUSEHOLD.
